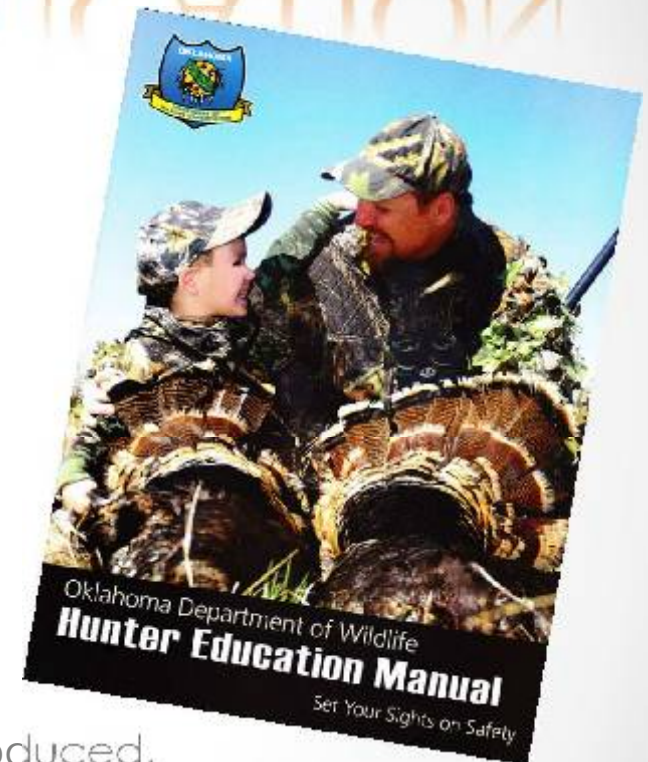
## HUNTER EDUCATION



- 2010 Record Year
  - 100 OKNASP Instructors
  - 17,600 Hunter Ed Certified
  - More OKNASP, FFA and others will be teaching in the classroom this year

# Educational Programs

## HUNTER EDUCATION



- New Hunter Education Manual
  - Oklahoma produced, one of the few state produced.
  - Complete control of content in manual.
  - 0.59\$ per copy to print, down from \$2.53 per copy when purchasing national manual.

# Educational Programs

## HUNTER EDUCATION



- Online Course Coming Soon
  - Will be only state with our own online course.
  - Will follow content in new manual.
  - When completed online students will be certified (similar to Boating Ed).



# Educational Programs

## EXPLORE BOWHUNTING



- 2010/2011 school year, 10 pilot schools.
- Additional 25 teachers trained this summer, adding 20 schools.
- Will train 15 more schools this fall.

# NE OK Bear Research



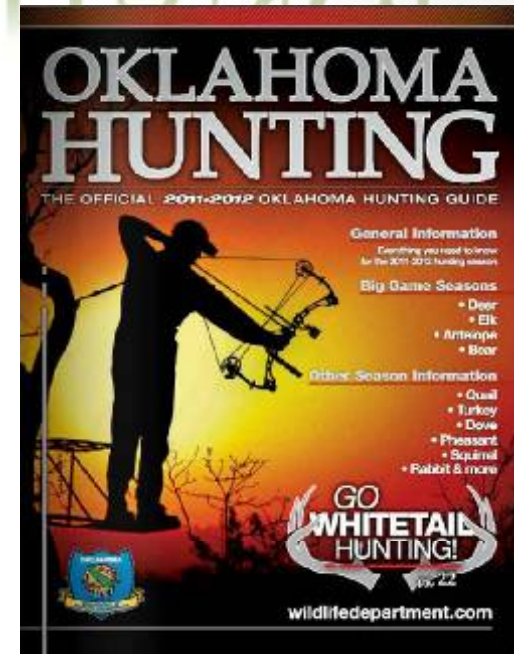
- SCI provided \$2,000 contribution.

- Satellite collars provide four GPS readings a day.

# Hunting REGULATION CHANGES



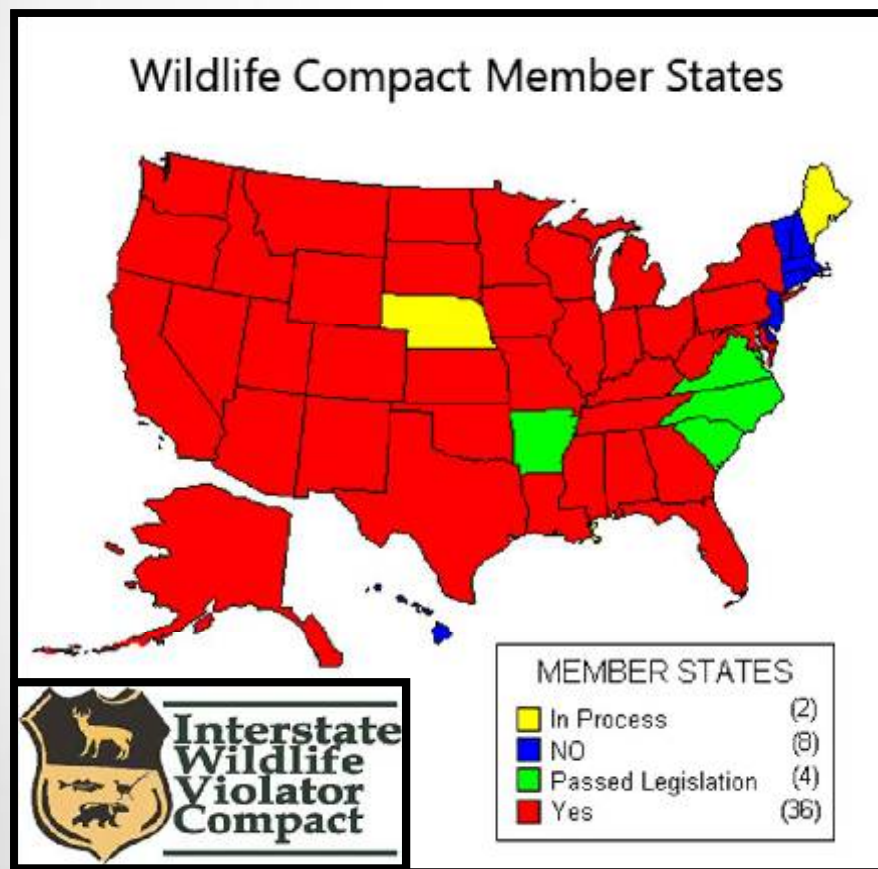
- Fiscal year license now available.
- Southeast region for Spring Turkey.
  - April 23 – May 6
  - Atoka, Choctaw, Coal, Latimer, LeFlore, McCurtain, Pittsburg & Pushmataha
- Southwest zone for dove season eliminated.
  - Entire state now.
  - Sept. 1 – Oct. 21 & Dec. 24 – Jan. 1

# Hunting REGULATION CHANGES



- Hunter Education
  - Actually changed Aug. 26
  - Age of exemption lowers from 36 to 31
  - Hunters age 8 – 30 can purchase apprentice designated license
  - All big game hunters under the age of 10 must be accompanied while hunting big game, regardless of HE certification

# Hunting REGULATION CHANGES



- Oklahoma now a member of the Interstate Wildlife Violator Compact
  - 36 states, soon to be 42
  - Violators can lose hunting privileges in all member states.
- New (non-wildlife) laws have increased trespassing penalties and altered provisions.



# Hunting SEASON OUTLOOK



- Deer Harvest Numbers
  - 2010-2011: 109,000
  - 2011-2012 Estimated: 95,000 – 115,000
- Antler growth should not be affected by drought.
- No rainfall?
  - Could affect deer patterns if they have to look harder for food.
  - Drought could make deer feeders and watering holes a good bet.

# Hunting SEASON OUTLOOK



- Dove season outlook is good
  - Need cool air up north
  - Waterholes should be good spots, especially if we don't get rain.
- Season Changes
  - Must follow US Fish and Wildlife Service framework.
  - Changes made to allow residents to hunt dove during Christmas break.
  - Changes also allowed for more simplified regulations.
